Studio Policy 2026-2027



I/We understand that the dance year of Precision Dance Company is organized on a 10 month schedule (two semester) schedule, August through May. The Company anticipates that each student will complete the dance year. The parents/guardians of a student who leave prior to completion of the year will be responsible for that month's tuition and any items/costumes ordered for that student. All registration, tuition, costume, shoe, shirt, supply, and competition fees are non-refundable.

I/We understand the monthly fee of \$55 for 45 minutes classes, \$65 for 60 minute classes, and \$75 for 75 minute classes must be received by the 15th of each month. Competition class is \$75 per month. There is a double-enrollment discount of \$10 per class per dancer for dancers enrolled in multiple classes. Additional costume or other fees may vary and will be posted with their respective due dates. For sibling groups of three or more dancers, the third dancer will be free, and fourth and any subsequent dancer will receive a 25% discount. Failure to pay tuition on schedule will result in the addition of a late fee of \$10, and excessive nonpayments or late payments may result in the dismissal of the student. If a dancer's fees are 60 days past due, they may not return to class until outstanding balance is paid. Nonpayment of fees will prevent a dancer from participating in the spring recital.

I/We _____, the undersigned parents/legal guardians of _____, student of Precision Dance Company, agree not to hold Precision Dance Company or owner liable for any injury which our child/children may incur while participating in any activities under the supervision of Precision Dance Company, its employees, and/or assigns. It is not the responsibility of Precision Dance Company to monitor students outside of their class period, and it is expected that parents will pick up and drop off their children in a timely manner. In case of emergency or unavoidable delay, please contact the studio immediately. Precision Dance Company takes no responsibility for any stolen or misplaced property on the studio premises. Choreography, costuming, themes, and policies remain intellectual property of Precision Dance Company, unless otherwise specified.

Precision Dance Company promotes kindness and teamwork to create an positive and respectful environment for dance. We will not tolerate bullying of any type. We expect dancers to be in appropriate dance wear, to behave properly during class and to be respectful of their teachers and peers. There will be a parent meeting after second behavior or dress code warning. The company reserves the right to cancel the enrollment of a child for reasons including, but not limited to, nonpayment or excessive late payment of fees, chronic behavioral disruption or bullying, and violation of studio policy by dancer or parent/guardian.

We understand that photos and videos of our child may be used in newspapers and other media as our child participates in activities concerning Precision Dance Company that are deemed of public interest, and Precision Dance Company may publish our child's picture in the newspaper, dance program book, and studio social media as advertising or basic studio publicity.

While our child/children are participating in this activity, we agree to allow director or representative of Precision Dance Company to handle any medical forms necessary for any urgent medical treatment which may be required, should our child be injured. **THIS IS ONLY IF PARENTS, GUARDIANS, OR EMERGENCY CONTACT CANNOT BE CONTACTED.** It is **IMPERATIVE** that you list your emergency contacts on the registration forms.

Please note that the following policy applies specifically to recital week. Attendance at both scheduled stage rehearsals for your dancer's specific recital(s) is mandatory for all dancers participating in the recital. Although these are referred to as stage or auditorium rehearsals, they are conducted as dress rehearsals for spacing, entrances and exits, music cues, and safety (costumes are not worn for these rehearsals unless otherwise specified). Dancers must attend at least one full stage rehearsal in order to be eligible to perform in that recital. Dancers who miss both stage rehearsals for their particular recital(s) will not be permitted to perform, as proper spacing, staging, timing, and dancer safety cannot be ensured. Exceptions will be considered only in the case of an emergency and must be communicated to studio management as soon as possible.
